EST entries for the SANA classes and Exhibition-ONLY horses are now OPEN.  
**Entires OPEN March 1st, 2024**    **Entries CLOSE May 17<sup>th</sup> 2024.**

Various updates will be posted to the EST website event page and alerts will be made on the EST Facebook Group as needed.

EST reserves the right to limit entries, split or combine classes, or cancel a class. *There will be no refunds once your entry is processed with the exception of a cancelled class.* SANA will allow POST ENTRIES, and will allow exhibitor horse substitutions for the same class.

There are no additional fees for Exhibition-Only horses other than the required stabling.

### **EXHIBITOR/ENTRY FORMS & REQUIRED DOCUMENTS**

EACH horse must have its own entry form. You must complete the *entire* form, including signature and date. You must also attach or mail a copy of the EST Liability Waiver.

If a horse is for Exhibition-Only, please complete the entry form and indicate under the "Class" section how you plan to participate: Rare-Steeds™ Pavilion and/or Breed Demos, or Drill Team member, etc.

To check-in and be assigned stabling, EVERY HORSE must have a current Coggins (within 12 months) AND a current Health Certificate (within 30 days) **INCLUDING in-state Virginia horses. You MUST bring hardcopies for the Stable Manager to KEEP. Anyone arriving with only digitals will be sent to the show office to pay for copies to be printed BEFORE unloading.**

Copies of registration papers are required for SANA entries – digital or hardcopy. If the entry is not registered, you must complete the provide proof of eligibility form and provide proof your entry is eligible to register (See SANA definitions) and you must indicate this by checking the appropriate line on the entry form.

### **PAYMENTS**

Fees for classes and stabling are listed on the Exhibitor form. Payment can be made via personal check or PayPal (plus 3% PP fee). For multiple entries as a lump sum, ALL entry forms must be complete to process, or all entries attached to the lump sum will be *pending* until payment in full is received. Entries can only be processed separately if payments are made separately.

Entries will not be considered processed until all forms, information fields, required attachments, and appropriate payments are received. Each horse processed will be assigned a SANA exhibitor number to be given out with exhibitor packets picked up during check-in at the Event/SANA show office in the REEL ARENA Concourse. If anyone has special needs for pickup, please contact Victoria Tollman, Event Coordinator or Bonnie McCutchen, Stable Manager.

Instructions for payment via PayPal are on the EST website. EST only accepts credit cards through PayPal. All payments by personal checks must be in US dollars to be processed. ***Be SURE to email or mail us the entry form.*** Your entry can not be processed until they are matched up.

### **VCH Facility REGULATIONS**

A list of Virginia Horse Center regulations can be found on the EST website under the 2024 Event page. Each exhibitor is responsible for being familiar with these regulations. VHC requires a negative Coggins within the last 12 months and EST is requiring a Health Certificate dated within 30 days for ANY horse, in-state included.

### **PARKING**

There is no parking fee if exhibitors park in the parking lot below the REEL arena.

## **ADMISSION**

Admission to the EST Event and the VHC grounds is free. All exhibitors are automatically listed as participants in the EST event. If you are bringing friends, volunteers, or family members, please provide Victoria Tollman (by email) the names and the breeds they are associated with so we know they are part of our event. Anyone not on this list for any day but Saturday (spectator day) may be subject to limited access, particularly in stabling.

## **STABLING**

All Festivale and SANA entries will be stabled in Barns 8 adjacent the REEL INDOOR Arena. All stalls will be assigned AT CHECK-IN by the EST Stable Manager, Bonne McCutchen at Barn 8. Every effort will be made to keep owners' horses and its breed together. Stalls are 10x10, permanent with three solid cement block sides. The front is a grilled sliding stall door. Electric plug ins are available at each stall. Fans are encouraged during summer. Layover stabling is available. Please contact Victoria Tollman, Event Coordinate for special arrangements.

## **BEDDING, FEED, & MUCK DISPOSAL**

EVERY stall with a horse must have 2 bags of shavings minimum. Bedding can be purchased directly from VCH facility or exhibitors can bring their own. Disposal of manure and bedding MUST be placed in designated on-site bins. Location of bins will be posted. Reasonable stabling rates were based upon stripping stalls. Upon vacating the event, ALL exhibitors are responsible for stripping their stalls to avoid a \$65 cleaning fee.

## **OTHER FESTIVALE ACTIVITIES**

We will be posting more information on breed demonstrations, the Rare-Steeds™ Pavilion, arena & farm obstacles & driving clinics, the Silent Auction and commercial vendor and association booths in June.
